### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

**General information** The severity of the symptoms described will vary dependent on the concentration and the length of exposure.

**Inhalation** Spray/mists may cause respiratory tract irritation.

**Ingestion** Due to the physical nature of this product, it is unlikely that ingestion will occur.

**Skin contact** Repeated exposure may cause skin dryness or cracking.

## SECTION 5: Firefighting measures

### 5.1. Extinguishing media

**Suitable extinguishing media** The product is flammable. Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog. Use fire-extinguishing media suitable for the surrounding fire.

### 5.2. Special hazards arising from the substance or mixture

**Specific hazards** Containers can burst violently or explode when heated, due to excessive pressure build-up. Bursting aerosol containers may be propelled from a fire at high speed. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Vapours may form explosive mixtures with air.

**Hazardous combustion products** Thermal decomposition or combustion products may include the following substances: Harmful gases or vapours.

### 5.3. Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. ### 6.3. Methods and material for containment and cleaning up

**Methods for cleaning up** Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Eliminate all ignition sources if safe to do so. No smoking, sparks, flames or other sources of ignition near spillage. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Small Spillages: Wipe up with an absorbent cloth and dispose of waste safely. Large Spillages: If the product is soluble in water, dilute the spillage with water and mop it up. Alternatively, or if it is not water-soluble, absorb the spillage with an inert, dry material and place it in a suitable waste disposal container. Flush contaminated area with plenty of water. Spray will evaporate and cool rapidly and may cause frostbite or cold burns if in contact with skin. Avoid contact with eyes. Avoid inhalation of vapours and spray/mists.
